SEARCH

Search Form: Enter a **specific ClientID** or the borough/program initial (ie, B for Bronx, K for Brooklyn, W for Westchester, I for Income Growth). For ALL clients, leave ClientID field blank.

Enter a **date or range of dates** the loan or grant was given. If no dates are entered, then all loans for given ClientID will appear (or all dates if no ClientID). **Type** of loan can be used to specify UT for utilities, CG for Community Grant, etc.

You can enter part of an **Agency Name** or leave it blank. If no Agency Name, then all agencies contributing to the specified ClientID will appear along with all loans during the given time period. If you enter an agency name, then only loans within the specified date range which also have a contribution to that ClientID will be shown.

NOTE: If you really just want to see Agency Contributions from a specified Agency to a client (or all clients) during a specified time period (or all dates), use the Agency Contribution links shown in the footer of this report.

An Example:

For this demonstration, we will select Loan Dates for the *6 days* in June 2020 (15th-20th). ClientID is set to “B” for all Bronx clients.

The Agency Name will be blank. No Type is entered.

The Tabular Data: Four grants were given to 3 Bronx Clients. One client contributed \$3,283 to his own assistance and also received ERAP funds of \$8,864. The other two clients received no agency contributions, nor contributed any amount to their own assistance. Grants were used for EP (Eviction Prevention), N (food/nutrition), and Utilities (UT).

SECOND EXAMPLE:

Press Search Again above the Tabular data. This time, add an Agency Name, or part of one. Here, we entered “Emergency”.

The Tabular Data: By limiting the search to the Agency name, we retrieve only one record of a grant, made in part with a contribution made from the Emergency Rental Assistance Program.

EXAMPLE THREE:

This time, we choose “W” for Westchester Clients, starting on January 1, 2022. How many landlords contributed to preventing eviction by forgiving part of the rental arrears or in some other way.
